1. EVENT DESCRIPTION AND AUTHORITY

The event will be conducted at the Phillip Island Grand Prix Circuit on 29th November and 30th November 2014 under the International Sporting Code of the FIA, the National Competition Rules of Confederation of Australian Motor Sport Ltd (CAMS), The Race Meeting Standing Regulations as in the current CAMS Manual of Motorsport, the Phillip Island Grand Prix Circuit Standing Race Regulations (Issue 08-2013), The 2014 Cue PSCRAA Sports Car Enduro Championship Handbook, the 2014 Victorian State Circuit Racing Championship Series Regulations, The 2014 Australian Formula Vee Nationals Sporting Regulations, these Supplementary Regulations and any Further Regulations or instructions Issued for the Meeting. The event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at www.cams.com.au. The Meeting is listed as a Multi Club Race Meeting that will incorporate a State Championship component (Victorian State Circuit Racing Championship 2014 Rnd 4 for Sports Sedans).

3. ENTRIES

The details of entries for this Meeting are listed on the Entry Form, which forms a part of these Regulations. Entries open on 14th August 2014, and close on 6th November 2014.

All drivers must be a member of a club affiliated with CAMS in Victoria or through a club affiliated with a CAMS Victorian Club. In the absence of any of the above, membership of a Victorian Club via the



promoter can be arranged at no cost. Each Driver must hold a minimum of a CAMS PCC competition licence unless noted otherwise against a particular event or specified otherwise in the Sporting Regulations for the relevant Championship/Cup/Series/Trophy/etc or;

- (a) hold a MotorSport New Zealand competition licence and Trans-Tasman Visa valid for the event; or
- (b) hold a minimum of the highest grade National Licence issued by a foreign ASN together with an authorisation issued by that ASN for the event;

Such Drivers and Competitors:

- (i) will be ineligible to score points in any Championship/Cup/Series/Trophy/etc connected with the event; and
- (ii) must receive an authorisation to compete from CAMS prior to the event;

Entries submitted before 23rd October 2014, will be at a discounted rate of \$380(except Sports Car Enduro entries which shall be \$410), and after that, shall be \$410 per entry (except sportscar enduro entries which shall be \$440).

A second driver may not be entered in the same car in the same category, except for the Sportscar Enduro Race. If a second driver is nominated to drive the car in a different category, a separate entry fee is payable. A surcharge of \$110-00 applies to any entry nominated for more than one category with the same driver.

Cheques should be made payable to PIARC Ltd and posted to The ENTRY SECRETARY at the address above. Entry forms must be completed in full, and accompanied by the appropriate entry fee to be considered for acceptance. The organisers reserve the right to accept or reject any entry without assigning a reason as detailed in NCR83. Entries for the entire event shall be limited to 400.

4. EVENTS

The event will be held at the Phillip Island Grand Prix Circuit which has a lap distance of 4.45km, with racing in an anti-clockwise direction and pole position on the right hand side.

5. FUEL & TYRES

Both leaded & unleaded racing fuel will be available at the circuit from JFP.

Competitors are reminded that fuel must be in accordance with Schedule G of the CAMS Manual. Tyres will also be available. To assist, competitors are requested to order their fuel in advance, on the forms provided.

6. MUFFLERS

Any vehicle which is not adequately muffled and/or exceeds the 95 dB(A) limit, in the judgement of the organisers, may be duly prohibited from further participation in the Meeting. There shall be no appeal against such a decision. Judges of Fact with regard to noise shall be the Chief Scrutineer and the Clerk of the Course.

7. DATA 1. TIMING TRANSMITTERS

Each vehicle must be fitted with a working DATA 1 Timing Transmitter fitted to their car prior to any scrutiny and during all sessions on the track. Competitors without a working transmitter during Qualifying sessions will not have the relevant times recorded and will be allocated grid positions accordingly. Transmitters can be purchased from Dorian Industries P/L or alternatively, a limited number are available for hire by prior arrangement with the organisers at \$50-00 per meeting plus bracket.

Transmitters are to be fitted to Formula Cars in the position agreed to by category management/association. For all sedan or production based vehicles that position shall be the left front footwell or right front footwell for left hand drive vehicles.

8. SCRUTINY

Targeted Scrutiny procedures will be applied at this meeting.

Competitors must present their appropriate CAMS Licence, CAMS affiliated car club membership, and vehicle logbook (if issued) at document checking / scrutiny.

All driver apparel shall be in accordance with Schedule D of the current CAMS Manual.

9. OTHER

Protests, if any, must be lodged in accordance with Part XII of the NCR.

The promoter reserves the right to cancel, abandon or postpone the event in accordance with NCR59.

Insurance will be provided in accordance with Appendix I of the CAMS Manual.

Timing will be by electronic means and the Chief Timekeeper is deemed a Judge of Fact regarding timing.

10. ANTI DOPING POLICY

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s). The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any area where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.

11. FRIDAY PRACTICE AVAILABILITY

The Circuit will be available for pre-event practice on Friday 28th November. The Organiser for the weekend race meeting is PIARC, but the Organiser of the Friday is the circuit itself, and thus a separate entry form is required, a separate entry fee is payable to the organisers for the Friday sessions, and if a garage is required on the Friday, a separate fee for that will be applied.

Note to Competitors.

This Meeting is conducted by the sport, for the sport and continues a tradition started by PIARC with the 1991 Vic Champs Meeting. Any extra spectators you can convince to come down to enjoy what "The Island" has to offer will be most welcome, and they will have free access to your paddock area. If you have any difficulties at the circuit, please contact the appropriate Officials of the Meeting and we will do all we can to help you.



GARAGE/SHED HIRE

Garages & Sheds will be available for hire for the two days over the period of the meeting. The cost of the South Garages numbered 1-40 will be \$350 without deposit. The cost of the Green Paddock Sheds, which have power, sealed access & forecourt, will be \$270 with no security deposit required. Over subscriptions to sheds may be combined at promoters discretion and placed in a North Garages (based on two shed hire fees equaling 1 north Garage fee)

Sheds can normally accommodate only one car with the roller door shut.

North Garages numbered 41-59 will only be available when all other sheds & garages are fully booked and they will cost \$450 without deposit.

Garage security deposits will no longer be charged but a charge will be made if the garage or shed is not left clean and the key returned to the Secretary's Office by the end of the Sunday's racing.

Two cars can be accommodated in each of garages 1-40 & up to three in garages 41-59.

Competitors nominating for a garage are required to share the garage with a nominated entrant or one selected by the organiser (from whom they should collect share of cost).

They should advise on this form which other entrant will be sharing the garage space with them. This, however, will not preclude those sharing from also nominating provided that they also advise who they think will be sharing with them. From this information, we will only list each entrant to one garage if appropriate.

If there is an over subscription for garages or sheds, the allocation will be at the organisers sole discretion. Those missing out will go onto a reserve list, but will have their hiring fee returned with Further Regulations.

Competitors with garages allocated to them may collect the key from the Secretary of the Meeting's Office on arrival at the circuit. Keys must be returned to the same office on the Sunday night before leaving the circuit and within 1 hr of the cessation of racing or a fee will be applied.
